

Asset Management

This document contains key information you should know about the D Series of the HSBC BRIC Equity Fund (the “Fund”). You can find more details in the Fund’s simplified prospectus. Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.

Effective on or about September 2, 2022, the Fund is closed to all purchases by investors.

Subject to receiving all necessary approvals, including unitholder approval of a change in investment objectives, effective on or about December 2, 2022 (i) the name of the fund will change to “HSBC Emerging Markets Fund II”; and (ii) the disclosure under the section “What does the fund invest in?” will change to “The Fund invests primarily in units of the HSBC Emerging Markets Fund. The HSBC Emerging Markets Fund invests primarily in equities and equity-related securities of well established, publicly traded companies whose main operations are located in emerging markets”.

What does this Fund invest in?

The Fund invests primarily in equity and equity-related securities of large, actively traded companies located in or which carry out the larger part of their business activities in Brazil, Russia, India and China (BRIC). To maintain a diversified portfolio of holdings, the Fund invests in companies from a broad range of industries through common shares, preferred shares, rights, warrants, American depositary receipts, and global depositary receipts.

The charts below give you a snapshot of the Fund’s investments on July 31, 2022. The Fund’s investments will change.

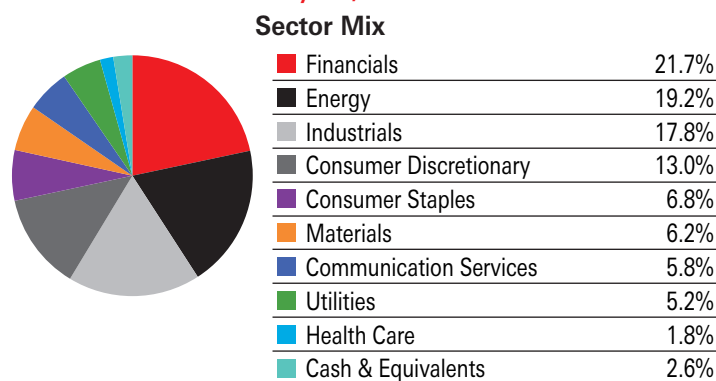

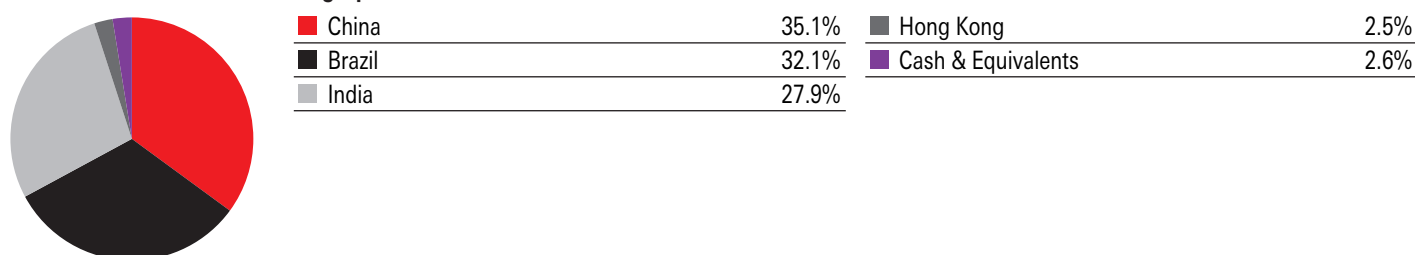

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much the Fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

HSBC Global Asset Management (Canada) Limited has rated the volatility of this Fund as **medium to high**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how the D Series of the Fund have performed since inception. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns*

This section tells you how the D Series units of the Fund have performed in past calendar years. However, this information is not available because the D Series have not yet completed a calendar year.

Best and worst 3-month returns*

This section shows you the best and worst returns for the D Series units of the Fund in a 3-month period. However, this information is not available because the D Series have not yet completed a calendar year.

Average return*

This section shows the value and annual compounded rate of return of a hypothetical \$1,000 investment in the D Series units of the Fund. However, this information is not available because the D Series have not yet completed 12 consecutive months.

* Subject to unitholder approval of the change in investment objectives, performance prior to December 2022 will relate to the Fund's previous investment objectives and may differ substantially from the future performance under its new investment objectives.

Who is this Fund for?

This Fund might be suitable for investors who:

- want to achieve long-term capital growth
- have a long-term investment time horizon
- have a medium to high tolerance for risk

! It is not suitable for investors with a low, low to medium or medium tolerance for risk or a short or medium investment time horizon.

A word about tax

In general, you pay tax on your share of the Fund's taxable earnings and capital gains you realize from redeeming your investment. The amount of tax depends on the tax rates that apply to you, and the type of earnings realized by the Fund (e.g. interest, dividends, capital gains, etc.) and whether or not you hold your investment within a registered plan, such as a Registered Retirement Savings Plan or Tax Free Savings Account. Keep in mind that if you hold your investment outside of a registered plan, you will receive a tax slip that shows your share of the Fund's earnings. You must report your share of the taxable earnings in your taxable income, whether you receive them in cash or have them reinvested.

Any tax slips you receive will show the amounts in Canadian dollars. In addition, you must calculate your taxable capital gains realized on redemption. When you redeem units of a U.S. dollar denominated Fund or series, the book cost of purchases and proceeds are also reported in Canadian dollars and may result in reported capital gains or losses from a change in the value of the Fund units and a change in the value of the U.S. dollar relative to the Canadian dollar.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell units of the D Series of the Fund. The fees and expenses — including any commissions — can vary among the series of the Fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

The Fund has different series. The fees and expenses are different for each series. You should ask about other series that may be suitable for you.

1. Sales charges

No sales charges apply to the D Series units of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's return.

As of December 31, 2021, the Fund's expenses were 2.44% of its value. This equals \$24.40 for every \$1,000 invested.

Management expense ratio (MER) This is the total of the Fund's management fee and operating expenses. HSBC Global Asset Management (Canada) Limited waived some of the Fund's expenses. If it had not done so, the MER would have been higher.	2.25%

3. More about the trailing commission

HSBC Global Asset Management (Canada) Limited does not pay your representative a trailing commission for the D Series units you own of the Fund.

4. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	The Fund may charge you up to 2% of the value of the units of a Fund when you switch or sell your units within 30 days of the date you purchased those units. For the purposes of determining whether the fee applies, we will consider the units that were held the longest to be the securities which are redeemed first.
Switch fee	Your representative may charge you up to 2% of the value of units you purchase when you switch your units to another fund, or to another series of the same Fund.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
